

Release Assumption of Risk & Indemnity Agreement

It is the purpose of this agreement to exempt, waive and relieve from liability for personal injury, personal damage, property damage, and wrongful death, including if caused by negligence, including the negligence of releases. "Releases" include Michigan Pond Hockey Sports Charities, dba Michigan Pond Hockey Classic (hereinafter referred to as MPHSC), its agents, officers, employees, sponsors, advertisers, affiliate associations, member teams, event facilities, event hosts, other participants, coaches, instructors, officials, and each of them, their officers, directors, agents and employees.

In consideration of the participant's registration and being allowed to participate in any manner in Michigan Pond Hockey Classic (hereinafter referred to as MPHSC), games, transportation, and any other activities and/or related events, participant and the parents or legal guardians of participant, on behalf of both the participant and themselves, HEREBY FULLY ASSUME THE RISKS OF INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY INHERENT IN, AND/OR IN ANY WAY CONNECTED WITH, ATTENDING, PARTICIPATING IN, AND SPECTATING AT THESE ACTIVITIES EVEN IF ARISING FROM THE NEGLIGENCE OF OTHER PERSONS EXECUTING A SIMILAR WAIVER AND RELEASE FROM LIABILITY, and WAIVE, RELEASE AND RELINQUISH ANY AND ALL CLAIMS FOR LIABILITY and causes of action, including for personal injury, property damage or wrongful death occurring to participant, arising out of participation in the above-described activities, and/or activities incidental thereto, whenever, wherever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that participant and participant's parents or legal guardians, may have are hereby waived, released and relinquished, and participant and parents/guardians, does so on behalf of our and participant's heirs, executors, administrators and assigns.

Participant and the parents or legal guardians of participant, on behalf of both the participant and themselves, AGREE NOT TO BRING ANY CLAIM OR ACTION AGAINST RELEASEES, which claims concern in any way death, injury, damage, or loss of any type or nature, which arise out of, are related to, or are in any way connected with attending, participating in, volunteering at or spectating at these activities, and/or which arise out of or are connected in any way with my use of, or my presence at event facilities at which activities are held, whether injury, death or disability, loss or damage is caused in whole or in part by negligence, gross carelessness, or other acts or failure to act of those persons or entities, and further agree to verbally share the risks and dangers referenced herein with anyone else they invite to view these activities. Participant and the parents or legal guardians of participant, on behalf of both the participant and themselves, agree that if any claim related to participant's injuries, damages or death is commenced against the releases, they shall defend, indemnify, and save harmless releases from any and all claims or causes of action by whomever or wherever made or presented for participant's injuries, damages or death.

I acknowledge that I have not entered into this agreement in reliance upon any representation, written or oral, express or implied, not contained herein. This agreement shall inure to the benefit of and be binding upon the parties' respective heirs, successors, licensees and assigns. This agreement shall be governed by and construed in accordance with the laws of the State of Michigan.

I certify that I, as parent/guardian, have the legal capacity and authority to act for, or on behalf of the minor child named herein. I do hereby execute this release on behalf of minor child. I hereby bind myself, the minor child, and all respective heirs, successors, licensees and assigns. I agree to indemnify and hold harmless the persons and entities referenced herein from any claims, actions and/or liabilities, which may arise against them as a result of, or arising out of my legal capacity or my authority to act for and on behalf of the minor child in the execution of this release and agreement or my execution thereof. I HEREBY AFFIRM AND ACKNOWLEDGE THAT I HAVE READ THIS DOCUMENT, FULLY UNDERSTAND THE CONTENTS THEREOF AND THE AFFECTS UPON MY LEGAL RIGHTS, AND AGREE TO BE BOUND THEREBY.
